

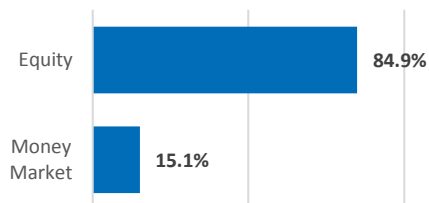

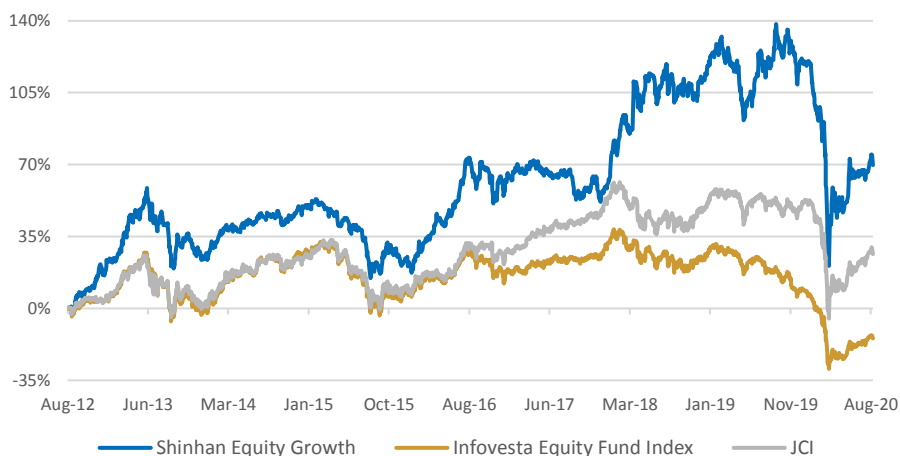

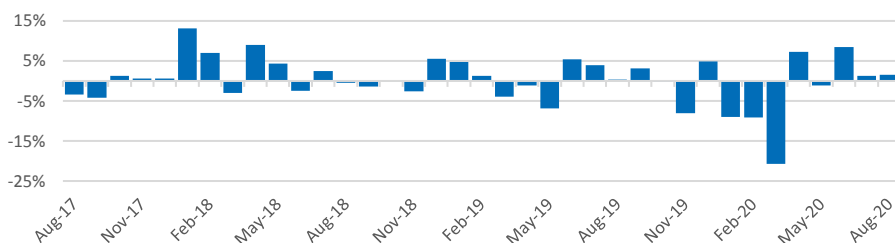
Performance Graph
