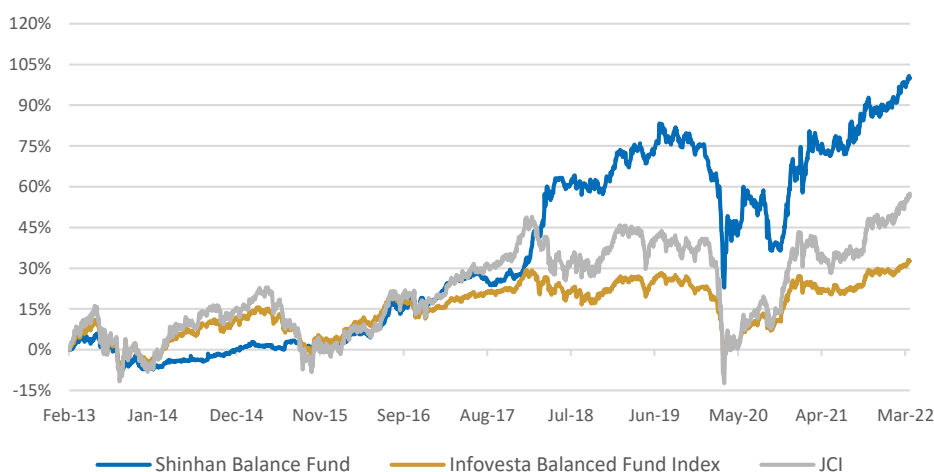

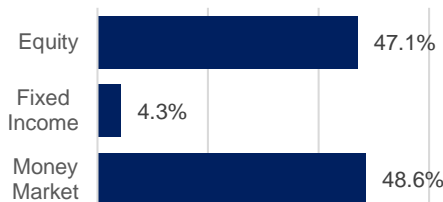

### Asset Allocation



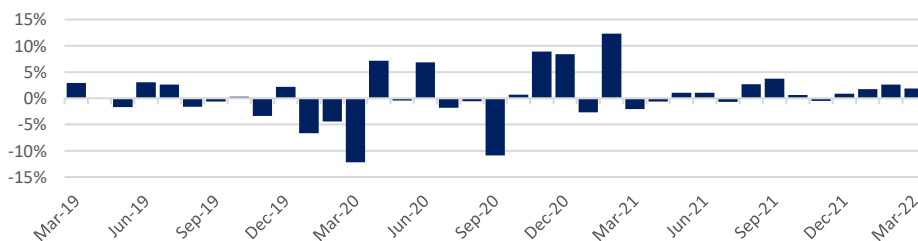
