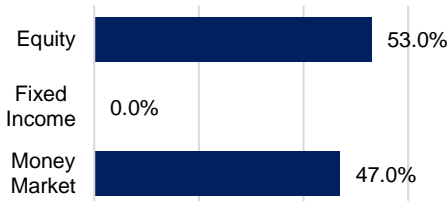
Performance Graph

Asset Allocation



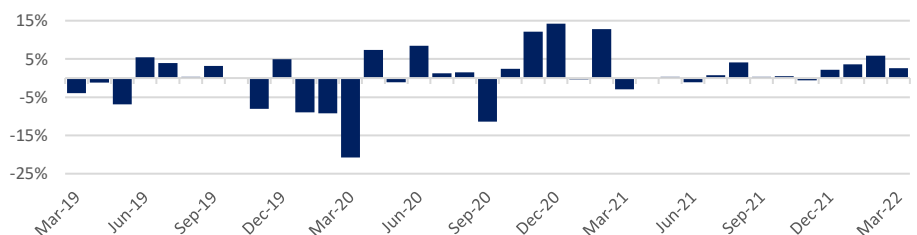
